ABOUT THE THEME MISSIO DEI—THE WORK & MISSION OF GOD

The American Lutheran missiologist, James A. Scherer, says, "For Luther, mission is always pre-eminently the work of the triune God—missio Dei—and its goal and outcome is the coming of the kingdom of God. Luther sees the church, along with God's word and every baptized believer, as crucial divine instruments for mission. Yet, nowhere does the reformer make the church the starting point or the final goal of mission, as 19th-century missiology tended to do. It is always God's own mission that dominates Luther's thought, and the coming of the kingdom of God represents its final culmination" (James A. Scherer, Gospel, Church, & Kingdom: Comparative Studies in World Mission Theology [Minneapolis: Augsburg Publishing House, 1987], 55).

As one of the Core Values of the North American Lutheran Church is Mission Driven, it is important for us to be reminded that this is not only our mission, our vision, our strategy, but it is "pre-eminently the work of the triune God—missio Dei!"

This year's NALC Lutheran Week completes a six-year focus on the Holy Trinity, concluding now with "God the Father Creates...in His Image," as the theme for the Braaten-Benne Theological Lectures. However, it seems appropriate to conclude this cycle with the theme, *Missio Dei*, as we celebrate the fact that everything we do as a mission-driven Lutheran body comes from God and His mission—that we are to go into all the world, empowered by the Holy Spirit, preaching the good news of salvation in and through Jesus Christ—to the whole creation!

Our prayer is that this year's Mission Convocation will indeed be a mission-oriented and Mission-Driven gathering! While there will be necessary times dedicated to reports, actions and elections—including the election of a bishop—highlights will be the several "On Fire for Mission" sessions, focusing on domestic mission, international mission and mission related to congregational life. These will begin with brief Bible study and devotional periods, followed by presentations on the theme, with extended time for table talk, reflection, breakouts, and strategies for taking it home. We are also excited to hold a Faith Formation Festival and the Gathering of the Women of the NALC earlier in the week.

The hope and prayer of all involved is that this will light a spark, or fan the flame, for mission. We pray that we will return home inspired and excited about *Missio Dei*—the work and mission of God in our local congregations, in North America and throughout the whole creation!

ABOUT THE NORTH AMERICAN LUTHERAN CHURCH

The North American Lutheran Church (NALC) is a growing Christian church in the Lutheran tradition, uniting more than 142,500 Lutherans from 490+ congregations across the United States and Canada. The NALC embodies the theological center of Lutheranism in North America and stands firmly within the global Lutheran mainstream. The NALC is a church family committed to the authority of the Bible as the inspired Word of God, and, in keeping with the Lutheran Confessions, believes all doctrines should and must be judged by the teaching of Scripture.

The NALC has embraced four Core Values which shape its common life: Christ Centered, Mission Driven, Traditionally Grounded, and Congregationally Focused. As a church centered on the unique Gospel of Jesus Christ, the NALC is animated by missions and evangelism, grounded in the 2,000-year tradition of Christian faith, and organized chiefly to serve our congregations. A renewed Lutheran community moving forward in faith, the NALC is focused on living out Christ's Great Commission to go and make disciples in North America and around the globe.

OUR CORE VALUES

CHRIST CENTERED

We confess the apostolic faith in Jesus Christ according to the Holy Scriptures. We affirm the authority of the Scriptures as the authoritative source and norm, "according to which all doctrines should and must be judged" (Formula of Concord). We accept the ecumenical creeds and the Lutheran Confessions as true witnesses to the Word of God.

MISSION DRIVEN

We believe that the mission of the Church is to preach the Gospel and to make disciples for Christ. We believe that making disciples—in our congregations, in our communities and nations, and around the world—must be a priority of the Church in the present age.

TRADITIONALLY GROUNDED

We affirm the ecumenical creeds and the faithful witness of the Church across time and space. We endorse the form and practices of the universal Church that are consistent with Scripture, particularly the office of the ministry and the tradition of worship under Word and Sacrament. We seek dialogue and fellowship with other Lutheran churches and with faithful Christians of other confessions.

CONGREGATIONALLY FOCUSED

We strive to be a church that is organized to facilitate the ministries of local congregations in a posture of servanthood and a spirit of partnership, through the provision of resources, connections and information.

OUR PURPOSE

The North American Lutheran Church exists for the purpose of offering a witness to the saving work of God the Father, in Jesus Christ, through the Holy Spirit, in order that all people would come to know and trust and believe in what God has accomplished for them in His Son. Consistent with Holy Scripture, the apostolic teaching and the Lutheran Confessions, our work as a church body and as individual congregations is based upon our Lord's Great Commandment—"to love the Lord your God with all of your heart, soul, strength and mind…and to love your neighbor as yourself" (Matthew 22:37–39)—and His Great Commission—"to go into the world and make disciples of all nations, baptizing and teaching in the name of the Father and of the Son and of the Holy Spirit" (Matthew 28:19–20).

OUR CALL TO DISCIPLESHIP

The call to discipleship and to making disciples is in our DNA. It identifies us as followers of Jesus Christ—we are disciples, desiring to grow each day as followers of His who live the sacrificial way of the cross in community with one another. It also defines what we do. Our calling is to make disciples—to live as witnesses of our faith to others, to proclaim to them what God has done for them in Jesus, to baptize them in His name and bring them into His family, and to support and encourage them as they grow in their relationship with Him and grow in their ability to share their faith with others.

OUR LEGACY

As a body of believers who trust in the promises of God in Jesus Christ and who follow the guidance of the Holy Spirit, our primary purpose of proclaiming the Gospel message of the kingdom of God will never change. We will, however, as the result of living in an ever-changing world, regularly review our strategies and commitments in carrying out that primary task of being ambassadors of the Kingdom—of forgiveness, healing, deliverance and wholeness—to a confused and broken world around us.

BRAATEN-BENNE LECTURES IN THEOLOGY

ABOUT THE BRAATEN-BENNE LECTURES IN THEOLOGY

The Carl E. Braaten and Robert D. Benne Lectures in Theology have been an integral part of Lutheran Week since 2009. The event originated as the Lutheran CORE Theological Conference, and came under additional sponsorship from the North American Lutheran Church in 2010. In 2015, it was renamed in honor of Carl E. Braaten and Robert D. Benne, prominent Lutheran theologians who organized and conducted the theological lectures for the first five years (2010-2014). The Lectures reflect a commitment on the part of the North American Lutheran Church, the organizers of Lutheran Week, and the series steering committee to the significance of theology for the future of North American Lutheranism.

Each year the series brings together leading theologians, biblical scholars and ethicists from across confessional and ecumenical boundaries to address key issues of Christian faith and practice. While the papers are scholarly in nature, presenters are asked to keep the local church in mind. Each paper is followed by a question-and-answer session, with audience members determining the course of the discussion. One of the highlights of the annual event is the roundtable panel session at the close of the lectures. This yearly event gathers an audience composed of laypersons, students, pastors, professional scholars and denominational leaders.

The conference theme for 2023 is God the Father Creates in His Image (Genesis 1:27). This is the second half of a study on God the Father begun in 2021, and the final installment of a six-year focus on the Holy Trinity. Theological anthropology will be at the forefront: to be created in the image of God – what does this mean for us? According to the apostolic faith, what is the nature of humanity, and what kinds of moral challenges does the church face in this respect when it comes to being in, but not of, the world?

THE REV. DR. NATHAN H. YODER

Director of Lutheran Studies, Gordon-Conwell Theological Seminary (Charlotte)

Pastor Yoder graduated with his Ph.D. degree from the University of Regensburg (Germany) in 2011. Yoder also holds the S.T.M. degree from Lutheran Theological Southern Seminary (2009). and the M.Div. degree from the Wake Forest University School of Divinity (2002).

Yoder has been heavily involved in the NALC since 2011. He currently serves on the Commission on Theology and Doctrine, as a member of the Lutheran Theologians for the Church (formerly called the "Younger Theologians Colloquium") and former dean of the Catawba Valley Mission District. He is also a member of the NALC Life-to-Life Discipleship team.

GUEST LECTURERS

DR. BOB BENNE

Jordan-Trexler Professor of Religion Emeritus and Research Associate in Religion and Philosophy, Roanoke College

Dr. Robert Benne is the Jordan-Trexler Professor of Religion Emeritus and Research Associate in the Religion and Philosophy Department of Roanoke College in Salem, Virginia. He has taught for 58 years and is currently Professor of Christian Ethics for the online Institute of Lutheran Theology based in Brookings, SD. In 1982 he founded the Roanoke College Center for Religion and Society, which the College named in his honor in 2012.

He was Jordan-Trexler Professor of Religion and Chair of the Religion and Philosophy Department at Roanoke College for 18 years. Before that he was Professor of Church and Society at the Lutheran School of Theology at Chicago for 17 years. A native of Nebraska and a graduate of Midland University, his graduate degrees are from the University of Chicago. He has lectured and written widely on the relation of Christianity and culture. Two of his fourteen books are relevant to the discussion below: *The Paradoxical Vision: A Public Theology for the Twenty-first Century* (Fortress Press, 1995) and *Good and Bad Ways to Think about Religion and Politics* (Eerdmans, 2010). Bob and his wife, Joanna, have been married sixty-four years. They have four children and eight grandchildren.

DR. PAUL BLOWERS

Dean E. Walker Professor of Church History, Emmanuel Christian Seminary

Dr. Paul Blowers is the Dean E. Walker Professor of Church History. He is a scholar of patristics and early Christianity and has written also on the Stone-Campbell heritage. He is a former president of the North American Patristics Society and associate editor of the Journal of Early Christian Studies, and in 2017-18 was a Henry Luce III Fellow in Theology.

His authored and edited works include *Visions and Faces of the Tragic: The Mimesis of Tragedy and the Folly of Salvation in Early Christian Literature* (2020), *Maximus the Confessor: Jesus Christ and the Transfiguration of the World* (2016), *Drama of the Divine Economy: Creator and Creation in Early Christian Theology and Piety* (2012), *Exegesis and Spiritual Pedagogy in Maximus the Confessor* (1991). He is co-editor of *The Oxford Handbook of Early Christian Biblical Interpretation* (2019) and has two works of translation of early Christian texts, *Moral Formation and the Virtuous Life* (2019), and *On the Cosmic Mystery of Jesus Christ: Selected Writings of St. Maximus the Confessor* (2003).

He also has articles in the Journal of Early Christian Studies, Vigiliae Christianae, Studia Patristica, Pro Ecclesia, Church History, Modern Theology, and Studies in Christian Ethics. He has also produced long essays for The Oxford Handbook of Early Christian Studies, the Cambridge History of

Christianity, The Oxford Handbook to Maximus the Confessor, and The Oxford Encyclopedia of Biblical Interpretation. He edited and translated The Bible in Greek Christian Antiquity (1997) and was a general editor of The Encyclopedia of the Stone-Campbell Movement (2004). Paul and his wife Sandy, a nurse and teacher, have four children and sixteen grandchildren.

DR. DAVID LUY

Associate Professor of Systematic Theology, North American Lutheran Seminary

Dr. David Luy is the Associate Professor of Systematic Theology at the North American Lutheran Seminary in Ambridge, Pennsylvania. He has published a book entitled *Dominus Mortis: Martin Luther on the Incorruptibility of God in Christ* (Fortress, 2014), has contributed to various theological journals and encyclopedias (e.g., *Luther Digest, The International Journal of Systematic Theology, Modern Theology, The*

Oxford Encyclopedia of Martin Luther, and the Oxford Handbook of Deification), and is currently at work on a monograph project entitled The Fate of Christocentrism in Modern Theology (Oxford University Press). In his spare time, Dr. Luy enjoys music, reading, hiking, and fishing.

DR. MICKEY MATTOX

Flack Family Foundation Chair and Professor of Theology, Hillsdale College

Dr. Mickey Mattox is Flack Family Foundation Chair and Professor of Theology at Hillsdale College. His interests include Martin Luther, the history of biblical exegesis, the doctrine of creation, and ecumenical theology. He is a member of the Academy of Catholic Theology and the International Congress for Luther Research. His authored and edited books include *Luther at Leipzig* (Brill, 2019), *Iohannes Oecolampadius: An Exposition of Genesis* (Marquette, 2013), *Changing Churches* (Eerdmans, 2012), and

Defender of the Most Holy Matriarchs (Brill, 2003). Mattox is Deputy Editor of Reformation & Renaissance Review. He was Associate Editor for the Oxford Encyclopedia of Martin Luther (2017) and is a contributing translator for Luther's Works (CPH). He is presently writing a book on Luther's cosmology entitled Sacred Cosmos: Martin Luther's Medieval Catholic Worldview. He and his wife Pamela are members of St. Anthony's Catholic Church in Hillsdale, MI.

DR. GILBERT MEILAENDER

Senior Research Professor of Theology, Valparaiso University

Dr. Gilbert Meilaender is Senior Research Professor at Valparaiso University. He taught at the University of Virginia (1975-78), at Oberlin College (1978-96), and at Valparaiso University (1996-2014), where he held the Duesenberg Chair in Christian Ethics. He holds the M.Div. (1972) from Concordia Seminary (St. Louis) and the Ph.D. (1976) from Princeton University.

Dr. Meilaender is the author of many books and articles in the field of Christian ethics. Among his books are *Friendship: A Study in Theological Ethics; Bioethics: A Primer for Christians; The Way that Leads There: Augustinian Reflections on the Christian Life; Not by Nature but by Grace: Forming Families through Adoption; Thy Will Be Done: The Ten Commandments and the Christian Life; and (an edited volume of readings) Working: Its Meaning and Its Limits. He is co-editor (with William Werpehowski) of the Oxford Handbook of Theological Ethics. He has served on the Board of Directors of the Society of Christian Ethics, as an Associate Editor of Religious Studies Review, as a Consultant Editor of Studies in Christian Ethics, and as an Associate Editor of the Journal of Religious Ethics.*

Professor Meilaender's work in the area of bioethics is well known. He is a Fellow of the Hastings Center and was a member of the President's Council on Bioethics from 2002 to 2009.

MISSION CONVOCATION PROPOSED RULES OF PROCEDURE

- 1. The business of this Convocation shall be as outlined in the official agenda distributed to the Convocation.
- 2. The rules set forth in the current edition of "Robert's Rules of Order, Newly Revised," shall govern this Convocation in all applicable cases, to the extent consistent with these rules and the agenda adopted by this Convocation, and according to the constitution of the North American Lutheran Church (NALC).
- 3. Once adopted, these rules shall not be amended or suspended except by a two-thirds vote of those present and voting at this Convocation.
- 4. The voting body for this Convocation includes as delegates: 1) all ordained ministers of the NALC, who are properly registered to attend; and 2) those laypersons who have been elected by congregations of the NALC as voting members, who are properly registered to attend.
 - 4.1 **A QUORUM** for conducting business is 50% of all delegates (see 4.0) certified in accordance with the process established in advance by the Executive Council.
 - 4.2 The Bishop or the Bishop's designee shall preside over this Convocation.
- 5. Each NALC officer and each person serving in a position subject to election by a Convocation will have the right of voice and vote, at this Convocation.
- 6. **Motions from the floor.** All motions addressing subject matter not included in the agenda, AND all amendments to motions of a complex nature must be submitted in writing to the Committee on Reference and Council no later than 6 pm on Wednesday evenings of the Convocation. See Rule 10 below.

7. Discussion during the Convocation

- a. Unless otherwise determined by a majority of those attending the Convocation, all speeches during discussion shall be limited to **two minutes**.
- b. Delegates who wish to request to speak to a motion or make a point of personal privilege may do so at one of the microphones on the floor of the convocation stating full name, congregation, "I would like to speak (for or against) the motion" or "I would like to make a point of personal privilege." Those requesting to speak to a motion will be recognized by the Bishop in the order received, alternating those speaking for and against.
- c. Delegates may ask a question of the Chair in the same way, by approaching a microphone, stating their *full name, congregation,* "Question for the Chair" and their question. The Bishop will respond as appropriate.

8. Nominations

8.1 Nominating Committee. The Executive Council shall submit to each Convocation for confirmation not more than five names of persons to serve as members of the Nominating Committee until the subsequent Convocation. The Nominating Committee oversees the nominating process for the elected positions of the NALC and solicits names of potential candidates from congregations. The Nominating Committee ensures that (1) all required information it deems necessary is disseminated, received, complete and in order; and (2) that each nominee, if elected, is willing to serve in the specified office for which s/he is nominated. Regarding open positions on the Executive Council, the Nominating Committee shall place in nomination at least two candidates for each open seat. The Nominating Committee submits to the Convocation a report that includes a complete ballot of candidates meeting all requirements including those in 8.2 below.

8.2 Nominating Process and Deadlines.

a. Nominations for the *Office of Bishop* shall be made by an NALC congregation or the Executive Council and all required

- information received not less than 90 days prior to the Convocation. A Convocational delegate may nominate an additional candidate from the floor on the first day of the Convocation provided that required information provided by other candidates is received by the Nominating Committee the first day of the Convocation and the latter is assured the candidate is willing to serve if elected, allowing a reasonable time to inform the voters prior to the first vote.
- b. Nominations for the election to open seats on the *Executive Council* and the *Court of Adjudication* may be made by an NALC congregation upon all required information having been received not less than 90 days prior to the Convocation. As an alternative, nominations for these positions may be made by a group of three delegates from three different NALC churches upon submission of letters of support and other required information 45 days prior to the Convocation.

9. Elections

- 9.1 For any ballot, a majority of the legal ballots cast shall be necessary for election.
- 9.2 For ballots other than for Bishop, if no candidate receives a majority of votes on the first ballot, the candidate receiving the least number of votes, plus ties, shall be eliminated. Thereafter, in each round of voting, if no candidate receives a majority, the candidate receiving the least number of votes, plus ties, shall be eliminated.
- 9.3 For ballots *for the Court of Adjudication*, if no candidate receives a majority of votes, the two candidates with the most votes shall be elected.
- 9.4 For ballots for Bishop, if no candidate receives a majority on the first ballot, all but the top four candidates by votes received, including ties, shall be eliminated. Thereafter, if no candidate receives a majority, the candidate receiving the fewest votes, plus ties, shall be eliminated until two candidates remain. When two candidates remain, voting shall continue until one candidate receives a majority.
 - 9.4.1 Before the second ballot, the top four remaining candidates, plus ties, will give a 15-minute devotion, "The Missio Dei" and

- the Future of the NALC to include one of the key scripture texts of the convocation.¹
- 9.4.2 b. If no one receives a majority of votes on the second ballot, the top three candidates, plus ties, remaining will have the opportunity to respond to written questions from the floor prior the *third* ballot.
- 9.4.3 If no candidate receives a majority of votes on the third ballot, voting shall continue until one candidate receives a majority of votes.
- **9.4.4 The exception** to the above rule occurs only if there are just **two nominees** for Bishop. In that case, **before the first ballot**, candidates will give a 15-minute devotion, "The Missio Dei² and the Future of the NALC," to include one of the key scripture texts of the convocation, AND the two candidates will have an opportunity to respond to written questions from the floor. All of this will occur **prior to the first ballot**.
- 9.4.5 There will be a time limit of 20 minutes during the questionand-answer portion of the election of Bishop process. All questions shall be posed to all candidates.

10. Committee on Reference and Counsel

10.1 This committee will serve during this Convocation, and include the General Secretary, a member of the Court of Adjudication, a member of the Executive Council, and two additional delegates to the Convocation, one clergy and one lay, appointed by the Bishop.

¹ **Acts 1:8** But you will receive power when the Holy Spirit has come upon you, and you will be my witnesses in Jerusalem and in all Judea and Samaria, and to the end of the earth." (ESV)

Romans 10:13-16 ¹³ For "everyone who calls on the name of the Lord will be saved." ¹⁴ How then will they call on him in whom they have not believed? And how are they to believe in him of whom they have never heard? And how are they to hear without someone preaching? ¹⁵ And how are they to preach unless they are sent? As it is written, "How beautiful are the feet of those who preach the good news!" ¹⁶ But they have not all obeyed the gospel. For Isaiah says, "Lord, who has believed what he has heard from us?" (ESV) Ephesians 2:19-22 ¹⁹ So then you are no longer strangers and aliens, but you are fellow citizens with the saints and members of the household of God, ²⁰ built on the foundation of the apostles and prophets, Christ Jesus himself being the cornerstone, ²¹ in whom the whole structure, being joined together, grows into a holy temple in the Lord. ²² In him you also are being built together into a dwelling place for God by the Spirit." (ESV)

² Missio Dei (sounds like *miss-ee-oh day-ee*) is a theological term referring to the "Mission of God" in the world.

- 10.2 Suggested items for consideration by the Convocation outside the adopted agenda shall be presented to the Committee no later than 6:00 pm on the first day of the Convocation. The committee will present a report to the Convocation in which the Committee will recommend a time for the Convocation to consider the proposals. This Committee will also receive and review all motions from the floor of a substantial or complex nature for grammar, clarity and to ensure it says what the offeror meant it to say, before the motion may be returned to the floor for action.
- 10.3 This committee shall sort the questions for the Bishop's election, as there likely will be questions that are similar in nature.

11. A parliamentarian and assistant parliamentarian shall be appointed by the Bishop. A chair of elections, appointed by the Executive Council, shall oversee the elections process. Election observers shall witness each ballot. The NALC Communications Director will instruct the convocation members on voting technology.

Our congregations and every parent need to know the dangers of human (sexual) trafficking and its devastating effects on young children and youth. Human trafficking is everywhere—schools, shopping malls, youth programs and churches. It is both an individual and societal sin against God. Victims come from both affluent and poor neighborhoods. At this very moment, children in this country and throughout the world are being seduced, coerced and kidnapped to be groomed as sexual products to be sold on the worldwide sex market. As the church has formed statements on the right to life for the unborn, it is important that we extend this position to victims of human trafficking. No parent or child is immune from this pandemic of organized crime. "Chosen," a brief film, will be shown about a young girl who was trafficked and was rescued by family members and friends.

NALC MINISTRY HIGHLIGHTS REPORT

Grace and peace to you from God our Father and our Lord and Savior Jesus Christ,

Our theme for this year's Lutheran Week, "Missio Dei–The Work and Mission of God," comes at the close of six years in which two years have been dedicated to each of the three persons in the Trinity–Father, Son, and Holy Spirit. The theme is appropriate because God, as a Triune God, has been on a mission from the beginning of time. Everything He has done and all that He has accomplished was ordained and set into motion for the sole purpose of saving the world and its people in Jesus.

No other mission comes close in importance to the one being pursued and carried out by God. No other purpose in life comes close in meaning and significance to the one given and offered to us in Christ. And no other reason for our existence and for the time we share in this life comes close to the reason we exist and why we have been brought together in the Church.

As I look back on this past year and reflect on what God has been doing since the North American Lutheran Church (NALC) was first formed, it is evident that God has been with us and blessing us from the start. Without exception, each year we have grown. Each year we have become stronger and more impactful in our witness. And each year there is growing evidence that the mission of God is being carried out in and through us.

I am encouraged by the progress we continue to make in implementing the Vision we adopted at our 2020 Mission Convocation. As you read through this report, you will see how God has been working to advance the commitments we have made together. Through the faithful ministry of our NALC Staff and the countless ways in which we have partnered with pastors, congregations, mission districts, and mission partners during this past year, our Lord's promise to build His Church through His people is being fulfilled. Despite the global pandemic that challenged all of us in ways we had not expected, there are encouraging signs that we are well on our way to recovery and to an increased opportunity for fruit bearing and life changing ministry.

The following is a categorized summary of the work being done in many key areas of our ministry.

NALC Life-to-Life Discipleship

It has been a little over a year since we introduced the NALC Life-to-Life Experience in Intentional Discipleship for Congregations. It has been well

received by many of our congregations and is being integrated into our seminary and internship programs. The Life-to-Life Discipleship team is currently working on a companion piece to address how to be more intentional in disciple-making within our family units and everyday lives. If you are interested in learning more, visit *nalclifetolife.org*.

Domestic Mission

There are currently 21 "Missions in Formation" and several new developing church plants in both Canada and the United States. Following Convocation, we are planning to expand these same efforts by encouraging and supporting mission districts and congregations in developing new house churches and faith communities. To aid the small church and rural ministry, which represents a growing percentage of NALC churches, an online resource titled, "Small and Rural Church Ministry," was developed by the NALC Renewal Team. Workshops and consultations are available for this essential ministry. Finally, since many NALC congregations face the challenge of an aging demographic, we are working to prioritize our Aging Ministry by offering workshops, presentations and consultations throughout our mission districts and congregations.

International Mission

On the International Mission front, last fall my wife, Mary, and I, along with the Rev. Dr. Gemechis Buba, the Rev. Dr. David Wendel, the Rev. Dr. Amy Little, the Rev. Dr. Eric Riesen and the Rev. Carol Fryer met with the leaders of the Evangelical Ethiopian Church Mekane Yesus, and the Evangelical Lutheran Church of Tanzania. We also visited the Rev. Martha Shanka, one of our Global Workers who is currently in Dubai.

Current Global Projects include the Leadership Project in the Middle East, the reconstruction of the Mekane Yesus Seminary in Ethiopia, and the new mission frontier in Kenya. Two new partner agencies have been approved: Bethany International and One Plus God Ministries.

Six new Global Workers will be commissioned during this year's Convocation. Dr. Randy Stubbs in Tanzania; the Rev. Sam Chim in Cambodia; the Rev. Dr. Thomas Thorstad who will be going to Laos; the Rev. Dr. Slavomír Slávik in Slovakia; the Rev. Aleksandr Gröss in Ukraine; and Dagaga Gamechu in Kenya.

Youth and Family

The key to youth and family ministry is strong relationships—encouraging young people in their relationships with Christ, the church, to their community.

Over the past year, we have prioritized ways to encourage those relationships by hosting events and planning new ones. We have hosted multiple Faith Formation Festivals, which strengthen, encourage, and equip anyone working with young people. We have organized speaking engagements with churches, local youth gatherings, and online confirmation classes. We are also planning a four-day Continental Youth Gathering, scheduled for July 2024.

NALC Disaster Response

NALC Disaster Response has recently responded to seven disasters: Kentucky flooding, California wildfires, Hurricane Ian in Florida, Ohio train derailment, Arkansas tornado/outbreak of 200+ tornadoes, and Oklahoma tornadoes. We have been working on Disaster preparedness for our volunteers. We have had nine trainings and 12 Disaster Response Sundays across the country, and we encourage congregations to reach out and schedule one at their church.

We have also had 25 "Stuff the Truck" events to help bolster our emergency relief efforts, but 15 regional warehouses need to be filled. Flood buckets, quilts, kits, and gift cards of all kinds are needed. Twenty servant event mission trips have been held in each of the states, and disasters listed above, and more teams of youth and adults are needed to help families rebuild their homes. We thank Jesus for amazing volunteers and we pray that God will continue to raise up faithful servants.

Lastly, the new Volunteer Training & Retreat Center is nearly complete—the Disaster Response Team encourages congregations to start planning a trip to the center in Caldwell, Ohio, with your youth and adults in 2024.

North American Lutheran Seminary (NALS)

This has been a full year for the NALS. In the past year and a half, we have called three new full-time faculty members: Dr. David Luy, Dr. Alex Pierce, and the Rev. Dr. Nathan Yoder. Drs. Luy and Pierce are at the seminary center in Ambridge. Dr. Yoder is the new Director of the Lutheran Studies Program at Gordon-Conwell (Charlotte). We also called the Rev. Jeff Morlock this year to serve as the Director of Vocational Discernment for the NALS/NALC.

In the Spring, the NALS released the first edition of the new NALS magazine, Word & Sacrament, and is preparing for the launch of its first podcast, Cardigan & Collar, hosted by Dr. Luy and Pastor Maurice Lee. Lastly, the NALS has a new Memoranda of Understanding with both Fuller Theological Seminary and Gordon-Conwell Theological Seminary to better promote the "spokes" surrounding our hub that is at Trinity in Ambridge, PA.

Call Process

The NALC call process is a prayerful discernment of ministry for congregations and pastors. In the past 12 months, 26 congregations have called a pastor to their congregation. There are 41 congregations currently seeking a full-time pastor and 37 pastors seeking a full-time call. The NALC call process website has been redesigned and is much easier to navigate and can still be found at thenalc.org/call.

Ministry & Ecumenism

Fresh Eyes for Mission summits, which aim at renewal, re-energizing and refocusing on mission within congregations, have been held all over North America since 2020. As of this Convocation, 35 have been facilitated and many positive responses have been received.

Ecumenism for Inter-Lutheran relationships has been continuing, with representation from myself, Pastor David Wendel, and other NALC appointments attending meetings with the USCCB Bishop's committee on Ecumenical and Interreligious affairs meeting and LCMS-LCC-NALC. We also are working on continued relationships, through Bishop Ray Sutton, Presiding Bishop of the Reformed Episcopal Church, to reconstitute the ACNA/NALC consultation.

The Commission on Theology and Doctrine has restarted post-COVID, continuing to oversee the Braaten-Benne Theological Lectures Series and Lutheran Theologians for the Church group (formerly Younger Theologians study group). We are also continuing to work on various NALC topics, such as the marriage and sexuality statement, sacramental practices document, non-Lutheran presidency and preaching statement of advice and counsel, and catechesis in the NALC.

Communications

This year saw expansion on our communications team with the additions of Alana Brooks and Steven Neaton. In its efforts to increase a sense of unity, identity, and testimony across the NALC, much of this year's efforts were directed towards new strategies for the NALS Network as well as communication overhauls related to the NALC candidacy and call processes. Additionally, new platforms were developed to support the ongoing work of our mission team, as well as to resource congregations launching financial initatives related to the 2020 Vision. Finally, we launched a weekly video series to give updates on our life and ministry together.

Operations Report

One of the major items we have been working on in "operations" is strengthening and streamlining the process we have for vetting and certification of pastoral candidates. The Candidacy Process has been reworked to be more relationship oriented, and the certification of pastors has been tightened up in terms of requirements for those who are coming to the NALC as non-Lutherans. A first call team of seasoned pastors was formed to provide ministry support for the newly ordained.

The OUSC (Ordination Under Special Circumstances) process has been revised and improved as we learn how to maintain the integrity of the process while providing pastoral support to congregations who are in "special circumstances." The Diaconate process is being established. Since August 2022, we have grown to 490 congregations. In the past year we have received 16 new congregations, two new mission starts, and have welcomed 19 new pastors who have gone through certification. We have also celebrated the ordination of eight new pastors.

Stewardship

For more than 8 years, the NALC Living and Giving Stewardship team has created and made monthly devotions available. They highlight faith and giving, and generosity and gratitude, and are aligned seasonally with lectionary readings.

Monthly stewardship messages will begin in August 2023, along with expanded topic resources available on the NALC website. New RESET workshops will be offered to mission districts come February 2024, and a new publication addressing the origin of giving in the Old Testament with the grace of giving in the New Testament will be published in August 2024. Mike Johnson, NALC Treasurer has published a micro-book on the newly formed NALC Foundation. Ask the Registration Table how you can pick up a copy here during Lutheran Week.

2020 Vision Financial Initiative (Today, Tomorrow & Forever)

One of the essential components to our 2020 Vision is to be in a strong enough financial position so that we can respond to ministry and mission opportunities as they arise. The purpose of the financial initiative is to increase the funding we have available for ministry and mission and to invest that money in ways consistent with our Core Values and our Lord's Commission.

Having kicked off our 2020 Vision financial initiative last August, we have

already received more than \$1.3M in commitments. Most of these have come from individuals who have the capacity and the heart for supporting our work financially. Other gifts have come from congregations as they strive to play a larger and more supportive role in the mission we share together.

During this first year alone, we have invested in our seminary, expanded our global workers, and increased renewal efforts in congregations. Our prayer is that commitments will continue to be made by individuals and congregations so that the legacy of faith we have received will be passed on to future generations, "Today, Tomorrow & Forever."

Executive Council

Since the 2022 Mission Convocation, the Executive Council has moved on important actions. Some of the highlights include: approving a request from Pastor Lalisa Daniel, Mission Director for Mekane Yesus, to translate the NALC Discipleship Manual into the Amharic and Afan Oromo languages; approval of funding to our mission partners as adopted by the previous Convocation; acceptance of a colloquy process for clergy from non-Lutheran backgrounds; and the adoption of the seminary model of a hub and spokes, with the three options for seminary education as presented by the NALS (North American Lutheran Seminary) Faculty and Staff. Women of the NALC

The Women of the NALC work together to serve as a resource, and to support the spiritual growth and flourishing of all women throughout the NALC. This year, they have worked to support their Mission Partners, NALC Disaster Response, and the Great Commission Society of the NALC. Some other highlights include their seasonal newsletters, re-creating their logo immediately recognizable as a part of the NALC, and the proposed operational guidelines update.

Lutheran Week Planning Team

The Lutheran Week Planning Committee, established in 2018, helps organize the robust nature of the annual event, whether online or in person. Working directly with the General Secretary and NALC staff, the committee functions as a forum to provide effective Lutheran Week planning and responsible budgeting reflecting the NALC's Mission, Ministry and Core Values. They meet monthly via Zoom.

In Summary

We are soon coming to the close of our 13th year as a denomination. In these so-called teenage years of our existence, we are addressing challenges and opportunities that were not there when we first started. Adjustments in how things are done, a rethinking of strategies being employed, along with the necessary changes in infrastructure that inevitably need to happen to support continued growth, are among the growing pains we are experiencing. At the same time, we continue to grow in numbers, our collective Gospel reach and impact are expanding, and lives are being transformed as they are drawn into a life-giving relationship with Jesus Christ.

Thanks to all of you for your faithful ministry, for your God-honoring service, and for the part you play in support of the work to which we have been called. It remains an honor to serve as bishop and a joy and privilege to serve with you.

REPORT OF THE TREASURER

Who makes you different from another?

PRAYER OF THANKSGIVING

The following reports are presented in a new Unified Statement format. The Operating Fund, Great Commission Fund and Theological Education/Seminary Fund are the principal areas of ministry that are budgeted. Additional funds, given to the NALC for restricted purposes, are recorded but not budgeted.

2022 REVIEW

The unified revenue of the NALC was \$3,025,566 against a budget of \$2,823,580 resulting in a 7% increase.

The unified expenses and distributions were \$3,140,059 against a budget of \$3,038,002 resulting in a 3% increase of expenditures over budget.

Net Income was projected to be (\$236,747). Actual Income was (\$114,493), an improvement of \$122,254 mostly due to an increase in congregational donations, and expenses for theological education and the seminary being less than budgeted.

Total Cash and Cash Equivalents ended the year at \$4,624,575. Of that total, designated/restricted funds were \$3,435,164 and unrestricted funds were \$1,189,411.

2023 FORECAST

The 2023 Forecast projects a slightly higher loss than the 2023 budget. This 12% difference is primarily due to forecast decreases in donations and Convocation registrations.

2024 PROPOSED BUDGET

A budget is a spending plan, a statement of faith, and a stewardship plan for fiscal responsibility. The budget tells a story of the mission and ministry of the NALC and how financially we move the vision forward. Every vision requires funding. Faith and finances are inseparable. The NALC budget is a statement of faith that the congregations and individuals we serve will value and contribute to the advancement of the mission and ministry of the overall church.

UNIFIED REVENUES

Congregational and individual donations to the operating fund were increased by 3%. Total donations of \$3,514,950 include Today, Tomorrow & Forever funds being allocated as follows: Operating Fund \$100,000, Great Commission Fund \$150,000 and Theological Education and Seminary Fund \$200,000. Additional other income brings the unified projected Total Revenues to \$3,627,700.

UNIFIED EXPENSES AND DISTRIBUTIONS

Unified expenses and distributions are estimated to be \$3,813,887. Total Unified Net Income is projected to be (\$186,187)

If the projected shortfall does in fact occur, then unrestricted funds will be reduced for the year. This is an important number to follow as the number will reflect the impact of the fiscal budget. It is much like a household whose expenses exceed income – debt either rises or savings decreases.

Long-term negative budgets can be harmful to any organization. There are four ways to balance a budget: raise revenue, cut expenses, use savings, sell assets or any combination of the four options. These decisions are painful but necessary to the overall fiscal health of an organization.

Please be assured the Executive Council and NALC leadership closely monitor the stewardship of these resources and will take decisive action to avert a negative trend from becoming a long-term detriment to the NALC.

- \$0 co-pay for generic medications
- No coverage for elective abortions or abortifacient drugs

Ancillary Benefits

- Life and AD&D: \$50,000 base life insurance policy with additional \$50,000 Accidental Death & Dismemberment coverage
- Short and Long-Term Disability: Protects a portion of your income to normal retirement age or beyond if still working

If you are flying out of the Will Rogers World Airport, the best way to travel from the Omni Hotel is via **Uber or Lyft**. It's about a 10 minute ride.


Additional parking is available for \$10/day at the Convention Center Parking, 15 Mick Cornett Drive, Oklahoma City, just east of the hotel.
